## FIRST ORDER OF BUSINESS

## Call to Order/Roll Call

## **FOURTH ORDER OF BUSINESS**

Presentation of Supplemental Engineer's Report Phase 1

Mr. Lahti presented the Supplemental Engineer's Report for Phase 1, dated November 2, 2023. Asked for the total projected costs for Phase 1, Mr. Lahti stated the total Phase 1 projected costs are \$25,314,084.59.

Mr. Smith presented Resolution 2024-01, also referred to as the Delegated Award Resolution, which accomplishes the following:

- Approves the issuance of two series of bonds, namely the Series 2023-1 Bonds related to Assessment Area One and the Series 2023-2 Bonds related to Assessment Area Two.
- Approves the forms of documents required for the financing, designates the Trustee and approves the Underwriter.
- Delegates authority to the Chair to coordinate with the Underwriter to execute documents on behalf of the CDD, provided all the parameters and conditions are met.

Mr. Smith reviewed the parameters of the Series 2023-1 bonds.

It was noted that, while the agenda letter title for Resolution 2024-01 has the incorrect amounts, the actual Resolution contains the correct amount of \$3,000,000 in each location.
